Pathfinders

Pathfinders is a large community-based organisation providing Supported Accommodation and Homelessness services, Family and Youth Support services, National Aboriginal Birth Certificate program, and Out of Home Care services. Pathfinders' services are located across the Mid North Coast and New England NSW.

The Intensive Therapeutic Care program aims to provide a home-like environment for young people who are unable to live at home, build positive coping strategies and maintain and develop links between the young people and their birth families and community. The program aims to meet high standards for health, education, vocation and social competencies amongst all young people.

The OoHC foster care program attends to the needs of children aged 0-18 years of age. The basis of this program is assisting authorised foster carers to meet the needs of children young people in all areas of life.

The Pathfinders SIL program supports young people on the path to independent living. Support packages are developed by caseworkers to meet individual needs of clients so they can confidently navigate life after care.



Pathfinders also offer IPA and ICM models of care to support to children and young people who require additional therapeutic support or have placement needs that are unable to be supported through foster care or ITC.

Role of the Therapeutic Specialist

The Therapeutic Specialist provides clinical leadership and consultation to the team. They also provide primary and secondary therapeutic support for children and young people in out-of-home care. This role includes managing the dynamic, transactional and systemic broader systems of support around the young person.

Essential Criteria

- Appropriate tertiary qualification(s) in Psychology, Social Work, Occupational Therapy, Mental Health or a related discipline.
- Post graduate training in relevant child, adolescent and family clinical practice, family therapy and systemic thinking is preferred.
- Experience in completing assessments for children and young people and using the findings to complete a comprehensive therapeutic written report or care plan designed to inform staff and child interactions and the Care Team's planning.
- A knowledge and understanding of Aboriginal culture and values and an awareness of the current issues faced by Aboriginal children, young people and their families.
- Practice knowledge relevant to working with traumatised and vulnerable children, young people and families such as: child development and the impact of trauma; including the ability to provide therapeutic clinical assessment and trauma informed interventions.
- A well-developed understanding of Attachment and Trauma Theories, their relationship to child abuse and neglect, together with an understanding of social, emotional and cognitive disabilities and an ability to assist others to understand their associated implications.
- Experience in providing supervision, secondary consultation, training and advice to clinicians, other professionals, staff and carers
- Proven highly developed interpersonal skills, emotional intelligence and excellent engagement skills, especially in engaging children and young people who have experienced significant trauma, disrupted attachment and demonstrate extreme emotional and behavioural dysregulation.



- Ability to work collaboratively and the demonstrated capacity to negotiate and liaise with internal and external stakeholders including, DCJ, other agencies and the community.
- Demonstrable analytical problem-solving skills, the ability to assess options and identify and implement creative, innovative and flexible solutions.
- Evidence of a holistic understanding of the complexity of the child protection and out-of-home care service system and the issues involved in providing services to statutory clients.
- Willingness to align personal values consistent with the values of Pathfinders, including a willingness to embrace the Sanctuary Model and principles.
- Willingness to sign and actively abide by Pathfinders Code of Conduct.
- Observe and actively support Pathfinders WH&S policy and strategy.
- Attend mandatory and other training as required.
- Participate in and promote continuous quality improvement processes.
- Promote an environment that is culturally safe and strengths focussed.
- Abide by principles and commitments of the Sanctuary Framework.
- Travel as required.

Conditions

This position is identified as child related employment and Prohibited persons under the Child Protection Act 2012 are not eligible to apply. The successful applicant will be required to provide a current Working with Children Check Number and a National Criminal History Check.

Applicants are also required to:

- Adopt Pathfinders program philosophy and engage in training when provided, including WHS.
- Provide a copy of unencumbered driver's license.
- Provide a current paid NSW Working with Children check number.

Purpose of position

The Therapeutic Specialist provides clinical leadership and consultation to the team. They also provide primary and secondary therapeutic support for children and young people in out-of-home care. This role includes managing the dynamic, transactional and systemic broader systems of support around the young person.



Reporting relationship and accountabilities

Therapeutic Specialist will:

- Be responsible to the National Director Child Youth and Family.
- Implement strategies and tasks set by the National Director Child Youth and Family to achieve the goals of Pathfinders.
- Participate in the day-to-day operations of the Young peoples' programs (OOHC and Disabilities).
- Nurture the relationships between all Pathfinders teams.

Specific tasks and responsibilities

Therapeutic Specialist will:

- Provide therapeutic leadership and trauma informed interventions, based on sound practice expertise, contemporary research and program guidelines that deliver positive outcomes for vulnerable children, young people and their families.
- Ensure that appropriate assessment procedures, risk assessment, therapeutic planning processes and outcome measurements are undertaken for each child or young person in the programs as required.
- Facilitate the development of Behaviour Support Plans and Therapeutic Care Plans.
- Facilitate group work staff especially in the areas of trauma and its impact on the child or young person.
- Facilitate regular reflective practice sessions for program staff.
- Collaborate with members of the care team to support children and young people to develop and maintain positive links within the local community.
- Work co-operatively with staff, the Department of Communities and Justice (DCJ), and other services; and consultation to provide strategies and plans to meet the mental health needs of Pathfinders Young people (particularly within OOHC and Disability programs).



- Report regularly through Supervision internally and external Clinical supervision process.
- Participate in organisation wide service provision, training, quality assurance mechanisms and service development.
- Assist in the development of quality assurance and quality improvement frameworks for trauma informed service delivery.
- Develop and maintain effective relationships with key internal and external stakeholders.
- Represent Pathfinders as required.
- Undertake other duties and responsibilities as required

Pathfinders across the New England, North West Tablelands and Mid North Coast

Pathfinders is now located in offices across the New England and North West Tablelands at Moree, Inverell, Glen Innes, Tamworth and Armidale and the Mid North Coast at Kempsey, Taree, Port Macquarie and Coffs Harbour.

Our services continue to grow with our organisation now supporting children, young people and their families with supported accommodation services, family support services, juvenile justice, youth work, child protection, family referral services and Out of Home Care services.

Pathfinders programs and services include:

- Youth social, recreational and vocational programs.
- Family referral services to ensure assistance gets to families and their children when they need it.
- Information and referral assistance to link client with appropriate support agencies.
- Refuge and supported accommodation services to young people.



- Full time support for young people in out of home care.
- Juvenile justice support services to assist young people to reintegrate into our communities.
- Child projection and family referral services.
- Field placement and training for local TAFE and University students seeking employment in human services.
- Provision of Therapeutic out of home care services, foster care support programs and foster care programs for children and young people under the guardianship of the Minister for Community Services.
- Provision of family preservation services, supervised contact, therapeutic camps/activities and after care services to vulnerable children, young people and their families.
